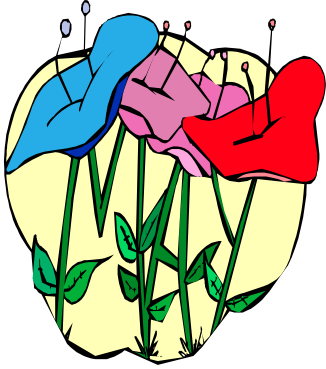

1. Collage artists will want to enter the collage exhibit with both ribbons and prizes judged by Chuck Scalin. Scalin has taught at VCU and has given workshops on collage at the VMFA. Entry fee is \$10 each for the first 2 paintings and \$5 each additional piece, 30% commission on sold pieces. Work should be dropped off at Uptown Gallery, 1305 W. Main St. from 11 am-5 pm May 27 and 28, Saturday, May 29 from 11 am-4 pm.

2. "Inner Sanctum" Artists in all media, including three-dimensional, are eligible to enter the August 3 to September 25th show. The exhibit will be judged by Joe Bivian, recent winner of the Best of American Artists In Acrylics, 2009 by Jay Kennedy Publishing, Inc.
